First Motion: I move to approve 65 provisional ballots and reject 25 provisional ballots as presented.

Second Motion: I move to certify the election results as presented.

DISCUSSION: I have attached the unofficial results of all ballots processed through the date and time of this canvass. All provisionals will be discussed with the Commission to either approve or reject the 90 provisional ballots. My recommendation is the following:

ACCEPT: 65
REJECT: 25

Each county had to do a post-election audit on 1% of their precincts on election day results; this also included one of the constitutional questions. We have 34 precincts so one precinct was audited. My audit board consisted of three volunteers, and they found zero discrepancies in every race that was audited. These results are part of the agenda.

There is a tie in Lookout Township for Township Clerk. Provided there are no provisionals that will break the tie the Chair will have to draw a name for a winner of the position. The names of the write-ins are Julie Grabbe and Larry Reichert.

Provisional ballots were researched and assigned the following situation codes based on the Kansas Election Standards developed by the Office of Secretary of State and the Kansas County Clerks and Election Officials Association.

4	A3	Registered voter had different name than on poll book due to marriage, divorce or legal proceeding and completed a new voter registration application. 25	A6	Voter was not registered.	NO	25-215 25-2302	Kansas laws require registration before voting.
55	B3	Registered voter moved anywhere in county and voted at new precinct.	YES	252316c(b)	Voter must complete a new voter registration application.
5	C1	Registered voter requested advance ballot, did not receive ballot and voted at polls.	YES	25-2908c	If CEO verifies that voter did not cast multiple ballots.
1	D1	Registered voter's name was found by CEO elsewhere in poll book.	YES	25-29089b)	Voter was inactive but was eligible to vote.

0	G1	Voter in the county fails to provide valid identification, votes provisional ballot.	NO	25-2908 (e) 25-3002(b)(8)	The law requires voter to provide ID in order to have ballot counted.
